Envera's customer service call center (1-877-936-8372) is open 24 hours a day; ready to assist our community with any gate access concerns! Please SAVE THE NUMBER (877-936-8372) IN YOUR PHONE CONTACTS as this is the number that will call when an oversized delivery, (i.e. moving company, a/c, plumbing contractor, etc.) is scheduled! Envera remotely operates the oversized truck entrance, at Morris Bridge Road gate, through a kiosk to an off-site security officer. The on-site security officers assist visitors and residents as their main post order but will assist the trucks at the oversized entrance if time permits.

**Please remember:** all visitors must be entered into the Envera system for security log purposes. Guards CANNOT accept phone calls from residents to notify of an expected guest, they are instructed to give residents the Envera customer service number or contact the Beach Club (813-986-1031). You may also enter the information and update your resident profile online (myenvera.com) or through the Smartphone App.

**Auto Burglary Safety:** Auto burglaries in New Tampa are at a high level. Lock your doors; Place visible items such as purses, packages and letters in your vehicle's trunk; Turn on your auto alarm.

## Feral Cat Concerns within our Community

Free roaming and feral cats make their homes wherever they can find food or shelter. There has been some unpleasant feedback from residents regarding the consistent sightings of feral cats within our beautiful community. Some have even expressed their frustration regarding property damage, as a result of male territorial spraying. Free-roaming/feral cats prey on birds and other types of wildlife and can be a nuisance to property owners. As of January 2014, Hillsborough County implemented the TNVR (Trap, Neuter, Vaccinate, Return) Program, with the hopes of reducing the number of feral and stray cats, as well as to improve the quality of life for cats, wildlife and people. Spaying or neutering cats not only stops behavioral nuisances, they also serve as a form of humane population control of un-socialized homeless animals. Behaviorally, male cats are no longer competing or

fighting with each other, spraying urine or roaming blocks away

from their neighborhood. Females no longer yowl to seek a mate or get pregnant with another litter of homeless kittens. Additionally, the TNVR Program provides vaccines, so the cats are healthier and do not pose a threat to public health.

Guidelines regarding the feeding and care-taking of free roaming/feral cats can be found under ordinance NO. 13-33 sections 6-20 of the Hillsborough County code of ordinances. It is important to note that under the guidelines of this ordinance, individuals who willingly choose to feed free roaming/feral cats for a period of up to two weeks or more are considered the cats "caretaker". This means it is up to that individual to properly follow the guidelines as listed in the ordinance. Representatives with the Hillsborough County Animal Resource Center have stated that the guidelines



of this ordinance are enforced.

Following the county guidelines for the TNVR Program not only ensures the safety and welfare of these animals and the people of our community, but will continue to maintain Cory Lake Isle as a premier living community.

## New Tampa in the City's Budget



As many of you have read in outlets like the Neighborhood News and Tampa Bay Times, City Council recently passed the budget for Fiscal Year 2018. New Tampa received funding for a number of projects that would substantially improve the quality of life for its residents. The projects funded in this year's budget are thanks, in no small part, to the New Tampa Council and the hard work and dedication of its members.

First, the budget includes funding for the construction and staffing of Fire Station 23. Completion of this facility will vastly improve the safety of our community. New Tampa continues to grow, and with more people there will continue to be more accidents. This has strained our current facilities and emergency responders. Fire Station 23 will go a long way

in delivering vital emergency services to New Tampa residents, and ensure the safety and livelihood of many. Ground breaking for this station is anticipated to occur by the end of 2017. I will be sure to update to community about this event.

There was also \$1.95 million allocated to expand the New Tampa Recreation Center and its programs. This project has been a long time coming. Currently, the waiting list for programs such as dance and gymnastics is well over 3,000 people long. This expansion will open up access to quality programs to children throughout our community. The inclusion is a testament to the passion of New Tampa families, who called and wrote the City Council for it to be included in this year's budget. During the final vote, they packed City Hall in a

show of support for the rec center and spoke eloquently about how the programs provided by the rec center improved their children's lives. It was moving to both me and my fellow councilmembers.

Finally, this year's budget included \$90,000 for design of a sensory friendly park in the New Tampa Area. Expanding access to those with sensory related disabilities, like autism, is



a cause that is near and dear to my heart. There are many in our community that have friends and family members that face challenges related to such disabilities. A sensory friendly park would be a true asset. It would also be the first of its kind within the City of Tampa; a flagship for the rest of the city to follow. I am proud to see that New Tampa will take the lead in expanding services for those with autism and related disabilities.

Things like public safety and parks have long stopped being wants in New Tampa: they are needs. Even so, these services will not come without cost. As many of you have undoubtedly read, the City of Tampa faces some lean financial times ahead. This is due to many factors, the most crucial being the City used bonds to pay for the downtown Police Headquarters 20 years ago. The debt accrued from these bonds was substantial, and the payments came due this year. To pay off this debt and meet the growing needs of our City, the Mayor asked the Council to approve a millage rate increase. We ultimately passed a 0.475/\$1,000 increase. I voted in favor of this measure because it was the responsible thing to do for the City and for New Tampa. This increase not only helped pay for desperately needed services in our community, but will help set the City back on the right financial path.

Many in New Tampa are expected to have some relief from this increase. In 2018 there will be a measure on the ballot to extend the homestead exemption, which would lessen the amount of property taxes paid by homeowners. The measure is expected to pass with ease. The projects and millage increase were endorsed by the New Tampa Council.

One of the most frequently encountered concepts in mathematics and problem solving specifically is the distance/time/speed formula.

This formula states that:

$$\text{Distance (D)} = \text{Speed (S)} \times \text{Time (T)}$$

Cory Lakes is approximately 3.5 miles (D)


