

MINUTES OF MEETING CORY LAKES CDD

A Regular Meeting of the Cory Lakes Community Development District's Board of Supervisors was held on Thursday, February 15, 2018 at 6:00 p.m., at the Cory Lake Beach Club, 10441 Cory Lake Drive, Tampa, Florida 33647.

SUMMARY OF MOTIONS PASSED:

- 1. The MOTION with all in favor, the recommendations for the gym survey as proposed by Mr. Hancz and the survey committee, with changes discussed by the Board, was approved.
- 2. The MOTION with all in favor, the January 18, 2018 Board of Supervisors Summary of Motions and Staff Directives, as presented, and Regular Meeting Minutes, as amended, the January 9 and February 8, 2018 Security Committee Minutes, the October 10, 2017, November 14, 2017 and January 9, 2018 LAF Committee Meeting Minutes, the January 23 and January 30, 2018 Gym Survey Committee Meeting Minutes, the January 3, 2018 Spirit Committee Meeting Minutes and the January 30, 2018 - February 13, 2018 Sunshine Board Online Workshop, as presented, were approved.
- 3. The MOTION with all in favor, Resolution 2018-02, Implementing Section 190.000 (3)(A)(2)(C), Florida Statutes, and Instructing the Hillsborough County Supervisor of Elections to Conduct the District's General Election [Seats 4&5], was adopted.
- 4. The MOTION, with all in favor, to write off \$327,746 from the Assets and Liabilities sections of the Balance Sheet, retroactive as of September 30, 2017, for audit purposes, was approved.
- 5. The MOTION with all in favor, allowing the TPD to institute a TAG community event by the Security Committee, with a to-be-determined date, was approved.

STAFF DIRECTIVES

FACILITIES MANAGER

- · Research hot dog vending machines and apprise the Board.
- Remove the two dead Bougainvillea bushes on the outside of the Cache gate and replace them with other shrubbery.
- Obtain updated proposals for street cleaning.
- Arrange for sidewalk repairs at 10716 Cory Lake Drive.
- Make sure that a tree at the Cross Creek entrance near the Watchtower monument was straightened.
- Repair LED light fixtures at the Cross Creek entrance and in other locations.
- Paint the new bathroom doors in the Clubhouse.
- Forward a list of ongoing issues with Allied Services to Mr. Castillo.
- Invite Allied Services representatives to next month's meeting to update the Board on their progress.

OFFICE MANAGER

- · Contact the School Board regarding moving the Java bus stop further from the intersection and learn what other options the District had to make the area safer for local schoolchildren.
- Inform Security and Admin Staff that the next few Gym Survey Committee Meetings could continue for as long as necessary.

DISTRICT MANAGER

- · Retrieve the total figure of the value of Cory Lakes-owned facilities from the Master Assessment Methodology Report for inclusion into the minutes.
- Check to see if the trailer storage area was for sale and apprise the Board.
- Forward a copy of the final

draft of the gym survey to Survey Committee members for review prior to distribution.

- · Mail out a reminder to residents regarding prepayments.
- · Prepare a packet, with photographs of damaged pavers and circulate it to the City of Tampa, Republic Services, Hillsborough County Public Waste and Solid Waste Departments and the Counsel Commissioner.
- Mail out the gym survey to Cory Lake residents allowing residents at least two weeks to respond.

CORY LAKES CDD & THE SUNSHINE LAW

The Sunshine Law The Florida Sunshine Law, established in 1995, is a series of laws designed to guarantee that the public has access to the public records of government bodies in Florida. Public records include all documents, papers, letters, maps, books, tapes, photographs, films, sound recordings, data processing software, or other material, regardless of physical form or characteristics, or means of transmission, made or received pursuant to law to ordinance or in connection with the transaction of official business by any agency.

WHAT THIS MEANS FOR YOU

Since the Cory Lakes Community Development District (CDD) is a governmental agency, it is governed by the Sunshine Law and subject to public requests. All residents that register with the Cory Lake Isles' CDD is asked to provide an email address to 1) use for official CDD communication regarding community events, notifications and reminders, 2) establish initial resident profile with Envera Next Generation Security. If there is ever an official public records request for homeowners

information, including email addresses, an email address can be subject to such request. If you wish to remove your email address from our records, please contact the CDD office. Please note: If you do not have a registered e-mail address on file, you will no longer receive community e-mails.

The e-mail address you have on file with MyEnvera is NOT subject to a public records request. If you wish to change the e-mail you have on file with MyEnvera, simply log-in to your account and update your information.

What to Plant

ANNUALS: Plants that can take summer heat include salvia, torenia, wax begonia, coleus, and ornamental pepper.

BULBS: Some lilies do better when their roots are crowded. Try planting Amazon, Aztec, and Clivia lilies in containers to increase blooming.

HERBS: Plant heat-loving herbs, including basil, Mexican tarragon, and rosemary.

VEGETABLES: Southern favorites to plant now are okra, southern peas, and sweet potato



What to Do

PESTS: Watch for thrips, scale, and mites on ornamental plants because they become more active in warm weather.

GARDENIAS: Distinguish between the normal yellowing of older leaves and the yellowing of new growth, which usually indicates a micronutrient deficiency.

OLEANDERS: Inspect chewed or ragged leaves for oleander caterpillars at work.

LAWNS: Watch for damage from chinch bugs in St. Augustinegrass and begin scouting for newly hatched mole crickets in bahiagrass lawns. Prevent or minimize disease by following proper cultural practices.

TOMATOES: Watch for pests, disease, and nutritional disorders on tomato plants.

Auto Burglary Safety: Auto burglaries in New Tampa are at a high level. Lock your doors; Place visible items such as purses, packages and letters in your vehicle's trunk; Turn on your auto alarm.

School Bus Safety (for non drivers)

We know that by law, as a driver we must stop for school buses when the lights are flashing.

However, as a parent or guardian who is at the school bus stop with your children, you also have a responsibility to ensure they are safe before and after the bus arrives.

Please make sure you

- Use sidewalks when possible to and from bus stops
- If you have to cross the street, make sure you are not distracted, and that you are aware of your child and what they are doing.
- IF YOU DRIVE to the bus stop, please DO NOT SPEED. We have had several reports of parents who are late making it to the bus stop, and actually chase down the bus at a high rate of speed.
- If you park your car and wait for the bus, DO NOT BLOCK THE FLOW OF TRAFFIC. As you are waiting for the bus to arrive, the traffic is busy, and you are causing hazards by parking on both sides of the street.

The CDD security companies, Envera
Next Generation Security and Allied Universal
Security, work in conjunction with one another
to provide gate access, roving patrol and video
surveillance of community gates and amenities.
Our uniformed Security Officers (SO) at the gate
play a vital role as the 'eyes and ears' of each and
every single vehicle that enters the community,
we expect a courteous smile, hand wave or nod
in acknowledgement to vehicles entering the
community through both gates (resident &
visitor), and we expect them to follow the Post
Orders. We uphold them to a much higher
standard than imagined.

As a resident, however, we each have a role to ensure the SO's can properly follow Post Orders by keeping our profile information up-to-date. There are various ways you can update:

- 1. Myenvera.com each resident has been issued a unique login, password and PIN number. The resident portal is user-friendly and can be accessed through a desktop, laptop as well as a mobile app that's available for Android or Apple.
- 2. Envera customer service 1-877-936-8372. This is a 24-hour center that is readily available and able to assist with updating your contact information (i.e. phone numbers, emails, changing of passwords) as well as adding guests to your list.
- 3. Beach Club office staff 813-986-1031. You can call the office and we are able to assist with adding a guest or vendor to your list as well as update contact numbers and email addresses.

If your guest experiences a long wait in the visitor lane, most likely that guest had not been added to the resident guest log prior to arrival and the SO must contact the resident to allow access. This is the Post Order the SO must follow and there are no exceptions! If the guest is not listed on the visitor list prior to arrival, expect a phone call for gate authorization, otherwise, your guest may be turned away.

Another issue that often arises is when guests (or residents) are in another vehicle and don't feel it's necessary to show their identification.
SECURITY OFFICERS FIRST QUESTION IS FOR IDENTIFICATION. There are a number of reasons for this information-address verification, correct name spelling to enter into the system, alerts security officer if there is a deny entry on the individual. It is nearly impossible for the security officers to remember over 960+ resident profiles, addresses, frequent guests, vehicles, etc.

And lastly, please be respectful and courteous to our security officers that are following the Post Orders. The Post Orders consist of industry standard procedures as well as tailored procedures for Cory Lake Isles. We are grateful for their service and one of the ways to show this is by returning the same courteousness with a smile and wave as well as maintaining our Envera profile so they may do their job with efficiency.

ampa, FL (Mar. 1, 2018) – It's time for a tie-breaker, Tampa Bay! Having both previously won the Treadmill Tuesday title, the Tampa Metropolitan Area YMCA and YMCA of Florida's First Coast are going head-to-head in the 2018 Treadmill Tuesday Tie-Breaker - a competition between the Tampa Bay and Northeast Florida communities for the greatest distance traveled on a treadmill.

This free friendly competition takes place Tuesday, March 27 from 6:30am-6:30pm and is open to YMCA members and nonmembers across the entire Tampa Bay and Northeast Florida areas, encouraging physical activity and healthy living among community members.

"It is no coincidence Treadmill Tuesday takes place on Diabetes Alert Day," says Tampa Y President & CEO Matt Mitchell. "Treadmill Tuesday brings the community together, encouraging one another to improve their health. With 26 million children and adults suffering from diabetes and 79 million adults having prediabetes in the nation, we want to spread public awareness to help prevent the deadly disease."

All Tampa Bay area community members are invited to participate in Treadmill Tuesday by completing a 30-minute treadmill workout at any Tampa YMCA location or by posting on social media. At Tampa Y facilities, staff will record the distance each participant walks, jogs or runs on a treadmill for 30 minutes. To join from home or other locations via Twitter or Facebook, participants should post a post-workout photo of the treadmill dashboard displaying the total distance. Social media participants should use #TreadmillTuesday tagging @ TampaYMCA.

This is the third consecutive year the Tampa YMCA will rally the community for Treadmill Tuesday. Last year, a total of 1,630 Tampa Bay residents completed 3,358 miles during the 12-hour event, surpassing the First Coast by about 21 miles. The year prior, Tampa lost to Jacksonville by 176 miles.

the night! This is a family oriented fun event. See the flyer in this edition of The Islander for ticket prices.



Board meeting will be the first Wednesday of the month going forward.

In February we followed up on all the roofs that may have been borderline at the end of the rainy season and now need to be cleaned before going into rainy season. We look at roof at least twice a year. We try to focus outside of the rainy season since it is difficult to get contractor out and scheduled because of the weather. We also hit a few of the landscaping issues that was spotted while out in about.

We will be focusing on Yards this summer. Keep in mind it is against the covenants to apply your own fertilizer and fungicides to your yard. These will be essential tools in Florida to keep your yard up and must be applied by a professional licensed contractor. We highly recommend you having a contractor in place who is routinely treating your yard. It is the time of year the weeds start growing again in the landscaping and the pavers in the driveway. We recommend making sure you have your driveway pavers sealed on a regular basis and this will both protect the pavers and reduce the weeds growing up in the cracks dramatically.

Remember the key to the violation process is communication with myself. The time to clear a violation is standard if you need more time or are having issues with a contractor please just send me an e-mail and let me know what is going on. Rory.harding@fsresidential.com
